## 3.1.2. Interpretation and Monitoring of Ends 2.4 "Financial Conditions & Activities"

In ther interpretations of 2.4.4 Meg and Sean had raised questions about how to interpret disbursing gift income. The board discussed the policy and did not come to agreement. The board decided to send 2.4.4 to the Policy Workgroup to clarify policy 2.4.4.

The question of 'material deviation' in 2.4.1 was raised, especially when compared with 'material deviation' in 2.3.1. There was discussion about whether 10% is a reasonable interpretation of 'material deviation'. The large majority of the board was comfortable with 10% as a reasonable interpretation.

A motion was made to accept the interpretations with the exception of 2.4.4. Motion Carried Unanimously.

Our Guest Observer Joe Sullivan made some observations and suggestions. Specifically he suggested that interpretations should include some identification of the metrics or information that will be presented to show complicance (limitations) or progress (ends). He suggested also 'defining the standard', e.g. when words like 'appropriate' show up in policies (like in 2.4.3), they should be defined in the interpretations.
